Please see the attached. Swift River Energy obtained this through a FIPPA request for Township of Muskoka Lakes records.

It seems that there is in fact a Crown lease for the location known as the Shield Parking Lot which is immediately east of Muskoka Road #169 and south of the of the Bala South Dam downstream channel. I really don't understand why MNR (Lands and Forests) would or could have provided such a Crown Lease as I thought that this was MTO property up to the year 2000 when MTO "downloaded" roads to municipalities; and in the case of the "Shield Parking Lot" to the MNR;

You may recall that originally we (through Tim Cavanagh) thought that this Shield parking lot was not MNR-administered/owned Crown land, but Swift River had a meeting with MTO in North Bay and it was determined that it was in fact MNR-owned Crown land (I recall that the plan wasn't deposited or something along that line).

Also, I do recall about 10 years ago that District lands staff (Paul Gavel I think) had provided the Township of Muskoka Lakes either a lease or sale of a portion of this location; the most northerly portion fronting the south dam channel. I assume that occurred as I recall that there were some improvements made including the cement sidewalk and railing for public viewing of the dam channel.

Would it be possible to fully review or confirm any land tenure or agreements for the Crown lands around the Bala dams that are under the administration of the MNR?

This seems to becoming an issue as you know. It seems that the Township may think they have either a lease or agreement for the park at the north end of the Bala North Dam. As well, I do recall some sort of agreement for the use of the Crown land beside the Bala South Dam; only for its "beatification" but nothing placed (shrubs, signs, etc) that would be considered permanent and would need to be removed for dam maintenance at any point in



"Site preparatory work is currently being planned. Yes, the weather may have some impact on the schedule, but only time will tell exactly how much impact," she said in her email.

"My understanding is that SREL has not obtained the full land lease, but has obtained a use permit from the (Ministry of Natural Resources and Forestry), and will be granted the lease pending their completion of some additional requirements," said Muskoka Lakes mayor-elect Don Furniss. "The permit will allow SREL to conduct preliminary work on the site."

McGhee went on to say that the project has been in the planning stages for over nine years now and the company is eager to move forward into the construction and ultimately the operation stages.

"This is an estimated \$20-million green energy construction project that is projecting over \$10 million to be spent in Muskoka over the next couple of years. Every time this project makes the news, we are flooded by emails and calls from local contractors and service suppliers looking to be involved in the construction of this project."

While there is no dates forthcoming about the progression of the project, McGhee said the company will continue to keep the community updated on its progress through the project website, on social media accounts, as well as through the mainstream local media.

Bala residents want power plant over and done with, says SREL official

BALA — Swift River Energy Ltd. (SREL) vice-president Frank Belerique doesn't believe the bulk of Bala residents are opposed to the proposed power plant any longer.

"I would disagree ... that the majority of people in Bala are opposed to the power plant," Belerique said. "I don't think it is the majority. I think there is a core group that I think is small, that continue to express their opposition to the power plant."

Swift River to start building Bala...

More than 80 per cent of Muskoka...

Belerique made the comments one day after Swift River co-hosted an open house in Bala on Dec. 8 on the proposed redevelopment of the Port Landing property.

He made his statement while discussing the comments he had received during the open house relating to the controversial plant project.

"What I am hearing from people is, 'It doesn't matter if I support the power plant or not, I am just tired of talking about it, get on with it," he said.

If true, that would be a change in opinion of the Bala population based on a poll taken two years ago.

The poll, conducted and monitored by Toronto-based research firm Protean Strategies, indicated in 2014 an average of more than 83 per cent of those surveyed answered, "No," to the question, "Do you think the proposed power plant at Bala Falls should be built?"


The percentage of "no" answers increased to 85 per cent for people who identified themselves as living in the POC 1A0 postal code, where the proposed power plant would be located.


The study was sponsored and paid for by the Bala Voice, a group of Bala residents, who have a Facebook page, but have not made a posting since September 2014.

Belerique said that, as far as the power plant goes, the project is still set to begin construction this coming spring.

Re: Proposed hydro-electric generating station at the Bala falls

As you may know, the public has many unaddressed public safety concerns for the proposed hydro-electric generating station at the Bala falls, for which the company you work for is the proponent.

As detailed in our letter of May 10, 2016 which was both hand-delivered to your office and e-mailed to you, we have previously sent you and your company several e-mails and letters on these concerns but other than your e-mail of May 10, 2016 confirming receipt we have not received any replies from you or your company. We therefore would appreciate a response to the concerns below.

1) Proposed downstream safety boom

- a) The attached graphic is a composite of:
 - A Bing satellite photograph of the area surrounding the proposed project.
 - An overlay of the proposed downstream safety boom taken from the June 25, 2014 approval which Transport Canada issued under the *Navigation Protection Act* for this proposed project.
 - An overlay of the flow simulation taken from the last page of the 2012 Addendum for the Environmental Screening Report for this proposed project. This simulation is for a flow through the proposed generating station of 98 m³/s, which historical flow data shows would occur an average of 21 days each summer.

Transport Canada has no mandate or expertise for in-water recreation such as swimming, wading, and Scuba diving. Also, as an unscheduled waterway under the *Navigation Protection Act*, Transport Canada has no responsibility for assessing boating safety in the Moon River. Therefore, their approval does not address these public safety concerns.

b) Transport Canada reports that the maximum safe water velocity for canoeing and kayaking is 0.5 to 0.7 m/s, yet your own company's information shown on this composite graphic shows the water exiting the proposed generating station would have a velocity of more than twice this, extending more than 160' **outside** and downstream of the proposed safety boom.

This fast water would be even more dangerous for people swimming, which is a popular activity in the area downstream of the proposed generating station.

In the *Addendum* for the *Environmental Screening Report* for this proposed project, it was stated in Section 6.2.4 and shown in Figure 6.4 that the operation of this proposed project would only make areas **within** the downstream safety boom dangerous.

It would therefore appear that this proposed project would not comply with the 2013 environmental approval received from the Ministry of the Environment and Climate Change, which requires that: *"Swift River Energy Limited must implement the Project in the manner it was developed and designed, as set out in the Environmental Screening Report"*.

c) Through a competitive process, Swift River Energy Limited was selected based on their July 2005 proposal in which the commitment was made that this proposed project would *"not generally diminish the public's enjoyment of the area for swimming, boating …"*.

As the waters made dangerous by this proposed project would extend outside of the proposed downstream safety boom, it would appear this statement in the proposal was inaccurate and misleading.

d) The Canadian Dam Association's 2011 *Guidelines for Public Safety Around Dams* defines a safety boom as a *"physical barrier to delineate a dangerous water area"*.

As the water made dangerous by the proposed hydro-electric generating station would extend outside of the proposed downstream safety boom, it would appear this safety boom would not comply with the Canadian Dam Association's public safety guidelines.

2) Providing warning to the public before operation would begin

- a) The Ministry of Natural Resources and Forestry's *Public Safety Measures Plan* for the Bala falls dams, March 2011, requires that the public be warned before flow is increased to the Moon River.
- b) Yet the May 24, 2012 Minister's decision for your environmental assessment notes your company has stated there would be no warning to the public before operation would begin.
- c) Historical flow data shows that your proposed generating station would operate in cycled mode and therefore start operation daily on about ⅓ of summer days.

It would therefore appear that your proposed operation would not comply with MNRF safety requirements.

Conclusion

- 3) It would appear the design and operation of the proposed hydro-electric generating station at the Bala falls would not comply with the:
 - a) Environmental approval received from the MOECC in 2013.
 - b) Proposal submitted to the MNRF in July 2005.
 - c) Canadian Dam Association's public safety guidelines.
 - d) MNRF's *Public Safety Measures Plan* for the Bala falls dams.



Turbulent water exiting the proposed generating station's tailrace would be:





Saturday July 26, 2008

- Mid afternoon received the call that there may be a drowning near our facility from our on-call personal.
- Arrive on site minutes later. Police, ambulance, fire department and Bracebridge Generation staff onsite.
- Helicopters perform aerial search of site looking for signs of the young man. Water is tea colored and makes it difficult to see anybody below a few feet of water.
- Family of young man arrived during search. OPP relations team occupying them as search continued.
- Search called off at dusk. Everyone left the site. Bracebridge Generation staff the last to leave and lock up.

Sunday July 27th, continued

- Less than an hour with the search and recovery unit, young man is found and brought to shore.
- This unit is very efficient, professional and quick. They were packed up and off site within five minutes of recovering the body.
- The local undertaker was onsite with the hearse, but was unable to traverse down the hill.
- OPP and Bracebridge Generation staff, placed young man in a body bag, placed on a gurney and carried him into the awaiting hearse.
- The family watched the events unfold. OPP professionals at their side.







Incident Review

- OPP informed us that there was a group of boys skateboarding in the area.
- They were looking for a place to swim to cool down.
- Local resident gave them directions to a public swimming area. We believe they drove past and ended up at our generation site.
- The oldest was 21, the youngest was 12. Jose was 14 years old. The 21 year old climbed over the rocks, jumped in and swam through the discharge from the tailrace and over to the rocks on the falls.
- The youngest refused to go, thinking it was too unsafe. Jose was coerced by his peers into the water where he attempted to swim though the current but was overcome and didn't make it.

This Thursday will be exactly one year since Troy and I met with your predecessor Stevie O'Brien, and as of today it has been five weeks since we met with you.

- I know that your staff feel my letters are repetitive, this is because they refuse to actually provide answers. To be blunt, SaveTheBalaFalls.com continues to pursue these issues because drowning unsuspecting tourists is unacceptable. That several of my most carefully-researched letters have not received any reply appears to be very telling.

SREL's selection as Applicant of Record was made based on information that responded to the Request for Proposal (RFP). The content of a proposal following a RFP or subsequent selection of the Applicant of Record does not require final plant design commitments, as MNRF is not responsible for approving designs (e.g. exterior aesthetic designs). Relevant legislative-based comments are often provided to the proponent by regulatory agencies during the Environmental Assessment process which often become specific requirements and conditions within subsequent approval and permitting processes.

The proponent has substantively complied with or followed the MNRF's 2005 Request For Proposal requirements and expectations which include the expectation that any potential waterpower site, such as the Bala North dam site, be reasonably optimized for its water power potential or generation capacity. It is our understanding that the current proposed design not only provides for consideration of reasonably optimizing the site for electricity generation in view of the completed Class EA but also incorporates design input from the community based design committee and provides for a publically accessible viewing platform, as per their original proposal.

Further we understand that the community based scenic flow committee has made recommendations on minimum flows required to ensure the outflow of the Bala North dam and Bala South dam continue to be an attraction to tourists, also provided for in their original proposal.
